

Miracles Memberships

Terms & Conditions

1. Absolute discretion is granted to **Miracles** to reject any application for privilege cards without ascribing any reason for doing so.

2. Members who have signed Term Contracts are governed by the rules of those contracts. Other memberships must give one full calendar months notice in writing to **miracles**, via the Club Manager, prior to membership cancellation.

3. Paid in full memberships are non-refundable. Memberships may be transferred under certain circumstances to a friend or relative by applying to the Club Manager and when all outstanding debts are settled. Membership can be extended if medical certificate exceeds 2 months.

4. Standing orders, annual or casual membership subscriptions. Please note that the banks will not give **Miracles** any authority to make any changes to the payments on standing orders; this means that **only you** can instruct your banks direct with any changes that need to be made.

5. Any outstanding monies are to be settled promptly to avoid **Miracles** withdrawing its services to members who are not fully paid up. Any cardholder that cancels their membership, but then wishes to re-apply may be charged the subsequent joining fee.

6. **Miracles** may refuse to renew a membership or cancel a membership and shall not be obliged to give any reason thereof.

7. No member may change their membership to either workplace or corporate.

8. Use of **Miracles** gym facilities is restricted to members and guests aged 16 and above who have undertaken instruction in the safe and correct use of equipment. Members guests, may use the gym at the discretion of **Miracles** staff.(a charge will apply)

9. Members and guests are particularly not to undertake strenuous physical activities for which they might be medically unfit and **Miracles** will not be in any way responsible for any harm which may come to a member or guest as a result of their Physical capability.

10. **Miracles** reserves the right to introduce withdraw or amend the types and/or the facilities available at any time and to increase or decrease the prices for services at any time.

11. Entry to **Miracles** is only permitted at the appointed reception area. Fire exits, which are clearly marked, are there in the interest of public safety and, in the event of a fire, members and guests are to make their way in an orderly fashion to the nearest available exit and assemble in the Car Park.

12. All members and guests **must** take a small towel in to the **miracles** gym when working out, in order to wipe down the equipment as courtesy to the next user.

13. Members and guests when working out at **Miracles** are asked to wear appropriate clean clothing and training shoes at all times.

14. Members and guests may not use the facilities of **miracles** while under the influence of alcohol, narcotics or other mood altering substances.

15. All members and guest are asked to shower before using any of the wet area facilities and after a sauna if the pool or spas are used next.

16. Under no circumstances are the toilet cubicles to be used as changing areas.

17. All members are kindly asked by the management team to carry their gym programme card when in the gym. This will show proof that you are a valid member and assist in letting our instructors help you achieve your goals.

18. All members are to undertake a Lifestyle Appraisal form. This is a requirement that must be carried out by all our members.

19. **Miracles** reserve the right to amend the rules at any time and without notice to individual members. Notification of any such changes will be posted on the notice board and in writing to all members of **miracles** gym.

20. **Miracles** does not accept any responsibility for loss or damage or injury anywhere on site including the grounds and car parks.

21. Please be considerate to neighbours when you park your car in the adjoining streets.

22. By your membership Application Agreement, all members accept and agree to be bound by the above rules.
